This document has following salient features which may require specific attention for your valuable comments:

1) The current revision (fifth revision) is being done to update IS 4707 (Part 2) in line with the latest EC 1223/2009 and to trifurcate it as follows: I. IS 4707 (Part 2) for GNRAS and restricted ingredients. II. IS 4707 (Part 3) for preservatives allowed with restrictions III. IS 4707 (Part 4) for U.V. filters allowed with restrictions Accordingly, in this draft revision only GNRAS -List of substances which must not form part of the composition of cosmetic products(Annex. A) and List of substances which cosmetic products must not contain except subject to restrictions and conditions laid down (Annex B) are included under IS 4707 Part 2.

In this draft revision, modifications in the List of Raw Materials Generally Not Recognized As Safe (GNRAS) And Restricted Ingredients For Use In Cosmetics are indicated in the track change mode for ease of reference as the list is very voluminous.

Please note that there are additions in the list which are highlighted in yellow, while some other modifications are indicated in track change mode.

The deletions from the list are made in red and marked with a strikethrough to indicate removal from the list and the reference of EU regulation for the removal is given in the comments.

The references of EU/ASEAN regulation for additions/deletions/modifications are given in the comments on the right side of the document.

Please examine the document and share your comments regarding further improvement in the document.

Last date for sharing the comments is : 5 September 2021

The comments should be shared in the prescribed template through this portal only; and the comments so received shall be taken up by the Sectional Committee for necessary action.
