The third revision has been made to incorporate the following major changes:- a) All amendments have been incorporated. b) Title and scope of the standard has been updated. c) Material and sizes have been modified. d) Requirement of pantyliner, maternity pad and period panty have been specified. e) Manufacture, workmanship and finish have been modified. f) The procedure and requirement of ability to withstand pressure after absorption have been modified. g) pH and hygiene testing requirement have been updated. h) The requirement of compostability has been updated. i) Optional requirement of anti-bacterial activity test has been specified. j) Sampling and criteria for conformity has been modified. k) Marking clause has been modified. l) References to Indian Standard have been updated.
