1) *Medical/surgical gowns and medical/surgical drapes are intended to be used to minimize the transmission of infective agents between patients and clinical staff during the surgical and other invasive procedures. This standard addresses the performance of medical/surgical gowns and medical/surgical drapes designed to protect against exposure of healthcare workers to blood, body fluids, and other potentially infectious materials during surgery and other healthcare procedures. This standard defines testing and reporting performance requirements levels for surgical gowns and surgical drapes manufacturers in order to provide information to end users that can be used in making informed decisions in the selection and purchase of surgical gowns and surgical drapes according to the anticipated exposures. This standard was originally published in 2019. The present revision has been made in the light of experience gained since its first adoption and to incorporate the following major changes:*
