1) This standard prescribes the requirements for hollow polyester filled fibre pillows which maintains the pillow's bulk and compressive resilience while in use , along with casing fabric requirements, which encase and protect the filling fibres and maintain the shape of pillow. The standard also includes specifications for an outer protective cover that safeguards casing and filled fibres from liquids, as well as preventing the passage of saliva , sweat into the pillow.
