- 1) This standard prescribes the specifications and guidelines for the coir non-woven stitched composite geotextiles made of a layer of bio-degradable coir blanket sandwiched between two layers of polypropylene/high-density polyethylene/low-density polyethylene (PP / HDPE / LDPE) netting used in rainwater or wind erosion control application in slopes of road and railway embankments, mine spoil dumps in hill slopes or earth work and road construction.
- 2) This standard does not apply to other types of erosion control mats made from natural material such as jute, straw and polymer fibers.
