The major changes incorporated in revision of this standard are: a) Relevant taxes and duties, wherever applicable, have been updated in calculation of unit rates to include building and other construction works (BOWC) Cess and GST. b) Provisions for contractor's overheads and profits have been indicated. c) The number of reuse for steel and wooden shuttering/formwork has been added.*
