Subject: Celebration of Constitution Day, 2020 - reg.

This has reference to letter F.No. N-21/31/2019-P&C dated 20 November 2020 of DoCA forwarding therewith a copy of letter No. Secretary (SJE)/SCD/2020 dated 17 November 2020 of Secretary, Ministry of Social Justice and Empowerment (Department of Social Justice & Empowerment), Government of India, and subsequent e-mail dated 24 November 2020 of DoCA regarding Action Plan for Constitution Day on 26 November 2020. 2. Accordingly, the Constitution Day will be celebrated in all offices of the Bureau. It is requested that since the Prime Minister's reading of the Preamble of the Constitution would be telecast live at 11 AM on 26.11.2020. This will be followed by a Pledge which will be administered at 11:15 a.m. from their suitable locations. A copy of the Action Plan for celebration of Constitution Day, 2020 approved by DG:BIS is enclosed for necessary action.



In this regard, DG:BIS, ADG,CVO & DDGs at BIS HQs will join the Hon'ble Prime Minister in reading of the Preamble at 11 AM on 26 November 2020 on Constitution Day, 2020 in Auditorium, Manak Bhavan, HQs. Rest of the employees of HQs will read the Preamble of the Constitution in their respective departments/seats.

4. All DDGs, HoDs and employees posted in ROs/BOs/Labs/NITS are also requested to join the Preamble of the Constitution, since the Prime Minister's reading of the Preamble of the Constitution would be telecast live at 11 AM on 26.11.2020. This will be followed by a Pledge which will be administered at 11:15 a.m. from their suitable locations..

5. It is also requested to send some photographs / self videos of pledge to TN&MD at tnmd@bis.gov.in directly, for uploading the same on social media platforms of BIS under intimation to the Administration Department latest by 27 November 2020.

Action Plan for the Celebration of Constitution Day on 26th November,
2020

During the monthly meeting of National Coordination Committee of Youth Organisations, it has already been decided by all the member youth organisations that during this month all the youth organisations would participate in campaign i.e. '*Ekta Hamari Pehchan*' for celebration of Constitution Day. The aim of the campaign is to enhance the knowledge and information about Indian Constitution and to spread awareness on fundamental duties across the masses by mobilizing the youth of the country.

The hashtags for this month would be # *Its My Duty* and # *Mera Kartavya*. The major activities during the campaign would be as under:

- Banners, posters on fundamental duties of a citizen.
- Self-pledge on fundamental duties in the time of Covid-19.
- Read the preamble to the Constitution.
- Posting of self videos of pledge taking on Social Media platforms.
- Online kartavya Samvaad.
- Dissemination of public messages on Fundamental Duties.
- Theme based cultural programmes, songs, Nukkad Nataks etc.
- Youth march, Foot patrols, rallies for mass awareness.
- Designing and distribution of e-posters and banners on social media.
- Theme based online poster making and painting competitions.
- Slogan & essay writing competitions at village and school /college level.
- Conduct of regional webinars. During the webinars, the activities such as 'Awareness Talks by prominent speakers', 'Screening of films on Fundamental Duties' etc. would be carried out.

Apart from above, the Department of Youth Affairs will conduct 'cleanliness drive at home and in neighbourhood' activity across the country to drive home a citizen's responsibility towards nature. The participants will post videos and photos of cleanliness activities done by them on social media with hash tag # *Its My Duty*.
