Subject: Guidelines for implementation of Amendment 1 to IS 1293: 2019, "Plugs and socket-outlets for household and similar purposes of rated voltage up to and including 250 V & rated current up to and including 16 A"

- 1. Amendment 1 to IS 1293: 2019 has been published. IS 1293: 2019 is under concurrent running with IS 1293: 2005 up to 23 October 2021. The last date for implementation of this Amendment is also 23 October 2021. Anyone implementing IS 1293: 2019 after 23 October 2021 shall implement it along with Amendment 1.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment within a week of issuance of these guidelines.
- 3. The significant changes brought in through the amendment is given below for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.
 - 1. Inclusion of the following varieties in the ambit of the Standard:
 - a. 6 A/ 2P (for non-rewireable plugs only)
 - b. 6A/2P+E
 - c. 16 A/ 2P (non-rewireable plugs only)
 - d. 6/16 A (Combined socket-outlets only, explicitly added in Table 2)
 - 2. For plug pins with insulating sleeves, tolerance on Insulation length of current–carrying plug pins has been specified.
 - 3. Editorial corrections
- 4. Consequent upon the issuance of the Amendment, existing Product Manual has been revised as Doc: **PM/ IS 1293/ 2/ Jan 2021**.
- 5. The guidelines for implementation of the revised Standard is given below:

A. <u>LICENSEES</u>:

- (i) All Licensees of IS 1293: 2019 shall implement the amendment by 23 October 2021. Licensees of IS 1293: 2005 shall implement the revised Standard IS 1293: 2019 along with the amendment. BOs shall ensure that no Licences are under operation without the Amendment after 23 October 2021. The status of implementation of the revised Standard with Amendment 1 shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable.

Verification of implementation of the revised Standard, wherever required, may be done during the next visit which may normally be completed within six months of the last date of concurrent running.

(iii) If the Licensee fails to complete all actions by 23 October 2021 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto 23 October 2021 and for such cases Applicant shall give a declaration that they will implement the amendment by 23 October 2021.
- (iii) Beyond 23 October 2021 no Licence shall be granted without consideration of the amendment.

C. <u>CHANGE IN SCOPE OF LICENCE</u>:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 23 October 2021 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
