This has reference to the subject mentioned above. The approved revised Product Manual for product “**Room Air Conditioners - Part 2 - Split Air Conditioners**” as per **IS 1391 (Part 2): 2018** has been hosted on the BIS website under “Conformity Assessment → Product Certification → Product Specific Guidelines → Product Manual”.

Guidelines for Certification of Air Conditioners (AC) having Indoor Unit (IDU) and Outdoor Unit (ODU) have been issued vide circular No. CMD-III/16: IS 1391 (Part 2)/IS 8148 dated 15 July 2020. Accordingly, in this revision of the Product Manual, necessary changes have been made in Labelling and Marking requirements of SIT and Possible Tests in a Day. Guidelines for Certification of ACs having Indoor Unit (IDU) and Outdoor Unit (ODU) have also been incorporated in the revised product manual as Annex F.

BOs are advised to send this Product Manual which incorporates Grouping Guidelines and SIT to all Applicants within 7 days. The SIT which has been incorporated in the Product Manual shall be implemented within 30 days.
