Subject: Extension of the period of concurrent running of IS 8472: 1998 and IS 8472: 2019

This has reference to the subject mentioned above.

IS 8472: 1998 has been revised as IS 8472: 2019. The guidelines for implementation of the above-mentioned revision was circulated vide note no. CMD-III/16: IS 8472 dated 02 05 2019. The last date of implementation of the revised Standard was 08 April 2020 which was further extended up to 07 July 2020 as notified vide CMD-III Circular No. CMD-III/General dated 27 March 2020.

In view of the difficulties in implementation of the revised Standard, the last date of implementation of IS 8472: 2019 has now been extended up to **07 July 2021**. All BOs may bring it to the notice of all Licensees and Applicants.

The other provisions of implementation laid down in circular no. CMD-III/16: IS 8472 dated 02 05 2019 shall remain the same.
