Subject: Guidelines for switchover of BIS product certification licences to 10 digits series number - reg.

With increase in the number of BIS certification licences, the series of licence numbers is being upgraded from time to time.

- 2) Presently, the 10 digit licence number series is in vogue. However, the earlier series of certification licence numbers are also continuing.
- 3) In this regard, all Branch Offices (BOs) are advised to take note of the following:
  - i) All the concerned certification licences shall be switched over to 10 digits series (by prefixing requisite number of zeroes) at the BOs through functionality provided by ITSD/C-DAC in the ManakOnline portal within one month.
  - ii) Endorsements to this effect are also to be issued by BOs to concerned manufacturers whose certification licence numbers are being prefixed with zeroes (including in the IT system) for switchover to 10 digits series number.
  - iii) Template cover letter and endorsement to be issued are enclosed as *Annexure-I* and *Annexure-II* respectively.
  - iv) The concerned licensees shall be advised to complete transition towards usage of ten digits series number (on product, packaging and other materials) within one year for which they may gradually complete the process by replacement of their tools /dies/ moulds/ packaging/ printing material etc, as necessary.
  - v) Within one year, the manufacturers shall confirm to concerned BO about status towards transition to 10 digits series number. For the cases where transition towards 10 digits series number is unable to be completed within one year, the manufacturers may request Head BO for additional time with adequate justification and specifying the final transition time. In such cases, the BO Head may consider and approve the extended final transition time.
  - vi) Progress in this regard shall also be checked/verified during surveillance and other factory inspection visits and also mentioned in the inspection report. Licensee shall be advised in discrepancy-cum-advisory (DAR) report to complete the process within the specified period.
  - vii) Until the switchover gets completed by the manufacturer, the usage of both 10 digits series number (with prefixing of zeroes) and previous series number by that manufacturer to represent its BIS certification licence shall be valid.

- 4) A public circular in this regard has also been hosted on ManakOnline portal under its bulletin section for information of stakeholders.
- 5) This issues with the approval of the competent authority.
