# Subject: Guidelines for implementation of Amendment no. 2 to IS 7887 – (Mild Steel Wire Rods for General Engineering Purposes)

1. Amendment no. 2 to IS 7887 has been published. The amendment shall be implemented with effect from 04 Nov 2021.

2. The significant changes in the standard through this amendment as listed in the Table are given below.
