Subject: Revised Product Manual incorporating SIT and Grouping Guidelines for IS 2553 (Part 2): 2019 with Amendment No. 2

This has reference to the subject mentioned above. The approved revised Product Manual (Doc No. PM/IS 2553 (Part 2)/2/July 2021) for product “**Safety Glass for Road Transport**” as per **IS 2553 (Part 2): 2019** has been hosted on the BIS website under “Conformity Assessment → Product Certification → Product Specific Guidelines → Product Manual”.

Following are the major changes in this revision of product manual:-

- a) Sample size- Sample size for agricultural tractors have been included
- b) Grouping guidelines- New variety of windscreens (added through this amendment) for agricultural tractors have been added.
- c) List of test equipment- New clause references added (Cl. 5.8.2, 5.8.3, 5.7.4) for test equipment as per the amendment.
- d) SIT- Definition of control unit revised to accommodate glazing for agricultural tractors (Table 1A of Standard) also. Reference of table 1A of Standard has been added for applicable tests in Table 1 of SIT. New test as per Cl. 5.5.2.1 has been added for double glazed unit as per amendment. New test as per Cl. 5.7.4 has been added for Flexible Plastic Glazing as per amendment. Additional requirements specific to Toughened glass windscreens for Agricultural Tractor as per Cl. 5.8 has been added as per amendment. Requirement for test equipment for many tests has also been changed from “R” to “S” .
