Subject: Guidelines for implementation of amendment no.3 to IS 695: 2020– Acetic Acid

1. Amendment No. 3 to IS 695: 2020 has been published with last date of implementation as 24 December, 2024
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
Table 1, SI No. (viii), col (6)	'ICP-OES has been added as an alternate method for determination of iron (as Fe) in addition to the existing method
Table 1, SI No. (x), col (6)]	'ICP-OES has been added as an alternate method for determination of heavy metals [(including iron) calculated as Pb, in addition to the existing method

3. Consequent upon the issuance of the amendment to Standard, the existing Product manual has been revised and is being circulated separately, through BIS website.
4. Since the changes to the standard due to the amendment issued are only in respect of addition of alternative test method for the determination of Iron and Heavy metals, no evidence of conformity needs to be sought from licensees. However, the licensee desirous for addition of the alternate test method is required to submit a revised declaration for additional testing equipment in Form no 2 as applicable which shall be verified during the next surveillance visit.
5. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
6. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 24 December 2024.
