**Subject: Guidelines for implementation of Amendment No. 1 to IS 10350 : 2020, Powder Hair Dyes.**

1. Amendment No. 1 to IS 10350 : 2020 has been published. The amendment shall be implemented with immediate effect.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
3. The changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance :

Clause No.	Change
Clause 1, Scope	It has been clarified through a new note under the clause that Powder Hair Dyes containing Henna (Mehendi) Powder are also covered in the standard
Clause 4.2, Ingredients	Requirements of Henna (Mehendi) Powder, if used in the manufacturing of powder hair dyes, have been specified i.e. it shall conform to IS 11142
Clause 5.3.1(a)	Marking clause has been modified by specifying marking of "Powder Hair Dye" instead of the "Name of the Material"

4. Product Manual based on existing SIT and to incorporate the amendment has been prepared and it is being circulated separately through BIS website, as Product Manual Doc : **PM/ 10350/ 1 January 2022.**
5. It is clarified through this amendment by a note that Powder Hair Dyes containing Henna (Mehendi) Powder are also covered in the standard and if Henna (Mehendi) powder is being used in the manufacturing of powder hair dye, it shall conform to IS 11142 : 2019. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
