Subject: Guidelines for implementation of Amendment No.2 to IS 16098 (Part 1):2013 - 'Structured-Wall Plastics Piping Systems for Non-Pressure Drainage and Sewerage: Part 1 - Pipes and Fittings with Smooth External Surface, Type A'

- 1. Amendment No.2 to IS 16098 (Part 1):2013 has been published. The last date for implementation of the amendment is **30 Sept 2021**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment immediately.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Requirement
7.6 & 8.4	Effect on Water requirement has been added
15.1.2.1 & 15.2.2.1	Marking details of batch number along with format specified

Note: BOs may also refer to the Lead Stabilizer in Polyvinyl Chloride (PVC) Pipes and Fittings Rules, 2021 notified by the Ministry of Environment, Forest and Climate Change through which every manufacturer and importer of PVC pipes and fittings shall ensure to comply with the limits of the lead as provided in the Schedule of the said notification.

- 4. Consequent upon issuance of the amendment, existing Product Manual has been revised as Doc: PM/ IS 16098(Part 1)/ 2/ June 2021.
- 5. The guidelines for implementation of the amendment is given below:

A. <u>LICENSEES</u>:

- (i) All Licensees shall implement the amendment by **30 Sept 2021**. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case, at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation as per IS 16098 (Part 1):2013 without the amendment after **30 Sept 2021**. The status of implementation of the amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports, as applicable. Verification of implementation of the amendment, wherever required, may be done during the next visit which may normally be completed within six months of the last date of concurrent running.
- (iii) If the Licensee fails to complete all actions by **30 Sept 2021** it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto 30 Sept 2021 and for such cases Applicant shall give a declaration that they will implement the amendment by 30 Sept 2021.
- (iii) Beyond 30 Sept 2021 no Licence shall be granted without consideration of the amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 30 Sept 2021 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
