## Subject: Guidelines for implementation of revised IS 14806:2021, Azospirillum Inoculants-Specification

- 1. This has reference to Gazette Notification Ref: HQ-PUB013/1/2020-PUB-BIS (280) dated 09<sup>th</sup> December 2021 as per which revised Indian Standard for Azospirillum Inoculants Specification as per IS 14806:2021 had been made effective from 6 December 2021 and the erstwhile IS 14806:2000 has been withdrawn w.e.f. 5 January 2022.
- 2. The salient changes in the standard through this revision as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised IS 14806:2021.

Clause No.	Changes
4.5 of IS 14806:2000	Test requirement for Moisture has been deleted
4.1 of IS 14806:2021	Minimum number of CFU of viable Azospirillium cells/g of carrier material has been modified
Note under 4.6 of IS 14806:2021	Number of institutions has been increased, from where the manufacturer may obtain the mother culture

- 3. The existing Product Manual has been modified to incorporate the above changes and it is being circulated separately through BIS website, as Product Manual Doc: PM/14806/2 February 2022.
- 4. Since the above change are only an allowance given to the manufacturer and does not require any change in the product or manufacturing/testing infrastructure, no evidence of compliance to the revised Indian Standard is required, from licensees.
- 5. All BOs shall inform the Licensees under their jurisdiction about implementation of the revised IS 14806:2021 within a week of issuance of these guidelines.
