Subject: Guidelines for implementation of Amendment no. 2 to IS 14929 : 2022 (Mixed Polyolefin Fibre Ropes).

1. Amendment no. 2 to IS 14929 : 2022 has been published. The last date of implementation of the amendment is **25th January 2025**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
Table 1	'Reference number 4' has been deleted.
National Foreword	Following new paragraph has been inserted after paragraph 5- 'This standard also permits 3-strand hawser-laid mixed polyolefin fibre ropes of reference number 4. The requirements of 3-strand hawser-laid mixed polyolefin fibre ropes of reference number 4 are given in National Annex B.'
3.2	'NATIONAL ANNEX B' has been inserted after NATIONAL ANNEX A, wherein the requirements of Linear Density and Minimum Breaking Force of 3-Strand Hawser-Laid Mixed Polyolefin Fibre Ropes (Type A) has been mentioned against 'Reference number 4' in Table 4.

3. All the changes to the standard through this amendment are editorial, none of which require any evidence of conformity to the amended standard to be established.
4. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
5. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after **25th January 2025**.
6. The above guidelines come into force with immediate effect.
