This has reference to the instances noticed at some BOs w.r.t. non-compliance by manufacturers of orders involving stoppage of use of Standard Mark ( ).

- 2) In this regard, it may be noted that when a licence is put under suspension or deferment or dormant condition and the manufacturer is not responding within prescribed time norms, the Branch Office should ensure that discreet visits are carried out to ensure that manufacturer has complied with orders of BIS.
  - i) The primary responsibility of undertaking discreet visits, to check for compliance of BIS orders w.r.t. stoppage of use of Standard Mark vests with Branch Office. These visits require only a limited time in the factory and Branch Office can plan their activities in such a manner that these visits can be combined with other works in the same area.
  - ii) However, in cases where the manufacturer has more than one licence and outsourced agencies (OSAs) are going for surveillance visit of operative licences, the OSAs are being asked to also observe and report for compliance of BIS orders for licences which are not operative.
  - iii) The existing provisions available in ManakOnline portal can be used to view such cases and data available can be utilised for monitoring purposes.
- 3) All ROs/BOs are advised to keep note of above and ensure periodic review and monitoring.
- 4) This issues with the approval of the competent authority.
