- **2**. The following actions may be taken up on a regular basis in order to keep the pendency to minimum possible in all offices of the Bureau till further order:
 - The system of Nodal Officer in each ROs/BOs/Labs//NITS including departments at HQs, who will oversee the institutionalization/continuation of activities covered in the Special Campaign may continue;
 - ii) All ROs/BOs/Labs//NITS including departments at HQs, may dedicate 3 hours every week for continuation of the activities covered in the Special Campaign across all officers of the Bureau; and
 - iii) The Nodal Officer of each ROs/BOs/Labs//NITS including departments at HQs, may review the progress of activities on a weekly basis and the HoD may review the progress on a monthly basis
 - iv) With the operationalization of e-Office Advanced Analytics Dashboard, the Bureau is fully empowered to monitor their performance on various parameters of the initiative 'Increasing Efficiency in Decision Making', such as the average number of distinct levels a file moves (Delayering), e-Receipts/e-Files adoption (Digitization).
- **3.** Keeping in view of above, all Heads and Nodal Officers of ROs/BOs/Labs/NITS including departments at BIS HQs are requested to comply the above and send the report to Administration Department at e-mail: administration@bis.gov.in, regularly.
- 4. This issues with the approval of the Competent Authority.
