Subject: Guidelines for implementation of Revised IS 2508 :2024, Polyethylene Films and Sheets — Specification

1. IS 2508:2016 has been revised as IS 2508:2024 and the date of withdrawal of IS 2508:2016 is **21st February 2025**.

2. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard

Clause No. of revised ISS	Change
Clause4 Composition	The raw material used for manufacturing natural film/sheet and for black compound shall consist of only polyethylene resins conforming to IS 7328.
Clause 5.1.4, Density	The final product density of the film/sheet shall be as prescribed in SI No. (i) of Table 1, Table 2, Table 3 and Table 4.
-----	Amendments issued to IS 2508: 2016 have been incorporated and cross-referred Standards have been updated

3. The guidelines for implementation of revised IS 2508:2024 are as given below:

A. LICENSEES:

a) For switchover to revised standard, Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports. All Licensees shall implement the revised Standard by 21st February 2025. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest.

b) BOs shall ensure that no Licences are under operation as per old Standard after 21st February 2025. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running. Any difficulty in implementation shall be brought to the notice of CMD-2 immediately after issuance of these guidelines.

c) BOs shall plan an early surveillance visit for verification of the implementation of the revised standard preferably within 30 days of switchover by the licensee.

B. APPLICATIONS FOR GRANT OF LICENCE:

i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.

ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only up to 20th February 2025 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 21st February 2025.

iii) Beyond 21st February 2025 no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.

ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard or up to 21st February 2025 whichever is earlier.

4. The above guidelines shall come into force with immediate effect.
