Sub: Implementation of Amendment No.2, JULY 2021 to IS 2112:2014

Amendment No.2 July 2021 has been issued to IS 2112:2014 “SILVER AND SILVER ALLOYS, JEWELLERY/ARTIFACTS– FINENESS AND MARKING” (Third Revision).

2. In this Amendment No.2, the marking clause 7.1 of the IS 2112:2014 has been revised with deletion of the marking of Assay Centre’s identification mark and Jeweller’s mark/ manufacture’s identification mark on hallmarked article.

3. As per amended marking clause 7, the hallmarked silver articles shall carry the following three markings only:

- i) BIS Mark along with the word “SILVER”;
- ii) Purity grade/ fineness
- iii) “Unique Alphanumeric ID” of the article issued by the Assaying and Hallmarking Center

4. The amendment has been gazette notified by Publication department with date of establishment of amendment 2 to IS 2112:2014 as 07 July, 2021 and the date till which the Standard without the amendment shall remain in force is 06 Jan, 2022.

5. ROs/BOs are requested to inform all BIS Registered Jewellers and all BIS recognized Assaying & Hallmarking Centers about the implementation of amendment 2 to IS 2112:2014.

AMENDMENT NO. 2 JULY 2021

TO

**IS 2112 : 2014 SILVER AND SILVER ALLOYS,
JEWELLERY/ARTEFACTS — FINENESS
AND MARKING — SPECIFICATION**

(Third Revision)

[Page 2, clause 7.1 (see also Amendment No. 1)] — Substitute the following for existing:

‘The silver and silver alloys, jewellery/artefacts shall be stamped with the Standard Mark in the case known as the ‘HALLMARK’ by BIS recognized Assaying and Hallmarking Centre only. The Hallmarked articles shall carry the following markings:

- 1) BIS Mark along with the word ‘SILVER’,
- 2) Purity grade/fineness; and
- 3) “Unique Alphanumeric ID” of the article issued by the assaying and hallmarking center.’
