Subject: Guidelines for implementation of Amendment No. 1 to Indian Standard IS 2347: 2023- Domestic Pressure Cookers

- 1. Amendment No. 1 to IS 2347: 2017 has been published. The last date for implementation of the Amendment is 11 May 2025.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment within a week of issuance of these guidelines.
- **3.** The significant changes brought through this Amendment as listed in the Table below is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.

- 4. Consequent upon issuance of the Amendment, existing Product Manual has also been revised as Doc: PM/ IS 2347/9/ February 2025. In this revision, changes have been made in requirements of raw material and Scheme of Inspection and Testing as per the Amendment.
- 5. The guidelines for implementation of the Amendment is given below:

A. LICENSEES:

(i) All Licensees shall implement the Amendment by 11 May 2025. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no Licences are under operation Standard without Amendment after 11 May 2025. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

- (ii) In order to establish conformity to Amendment, licensee who are supplying pressure cooker with visual pressure indicator, shall submit test certificates of material for rubber parts and electroplated or anodized parts, as applicable to the component, as evidence of conformity to Amendment.
- (iii) Verification of implementation of the Amendment, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee.
- (iv) If the Licensee fails to complete all actions by 11 May 2025 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without Amendment. However, if the Applicant is desirous of considering the application as per the Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Amendment, Licence will not be granted without Amendment.
- (ii) Applications which are recorded henceforth may be processed with or without Amendment. Processing of Applications without Amendment shall be permitted only up to 11 May 2025 and for such cases Applicant shall give a declaration that they will implement the Amendment by 11 May 2025.
- (iii) Beyond 11 May 2025 no Licence shall be granted without consideration of the Amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without Amendment shall be permitted only upto the date of implementation of the Amendment by the licensee or up to 11 May 2025 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
