Subject: Market survey of non-ISI marked goods

1. As desired by Competent Authority, a market survey drive is to be carried out by all BOs in the month of October 2022 for assessing the quality of non-ISI marked goods against the requirements specified in relevant Indian Standards as per Annex - I.
2. The products identified are common consumer products and it is expected that non-ISI goods are easily available in the market.
3. Complete testing facility is available for these products in BIS laboratory as indicated in Annex -I.
4. Efforts should be made for drawl of all brands of the listed product as per the Annex -I, as may be available under the jurisdiction of the BO.
5. The samples are to be preferably sent to the labs identified in Annex - I.
6. A google sheet has been created for monitoring progress of the survey. The sheet can be accessed through the link: <https://docs.google.com/spreadsheets/d/1KG3Hw6-ip5-ML3O3En0dIDWLY6Qw8rJvrktYYuo4a5Q/edit?usp=sharing>
7. The columns highlighted with yellow color of the google sheet are to be filled by the BO after receipt of the Test Report from the laboratory.
8. BOs are advised to enter the details of samples drawn by them as soon as they draw the sample, so as to avoid drawl of the same brand by different BO.
9. A minimum of 25 samples of each product are to be drawn by all the BOs combined. The manufacturer of the product may not be located in the jurisdiction of the BO who is drawing the sample.
10. In case, any BO finds any difficulty in drawl of any particular product, the same shall be brought to notice of CMD-II/ CMD-III at the earliest.
11. This issues with the approval of Competent Authority.
