4. In view of above, Heads of all ROs/BOs/Labs/NITS including BIS HQs are hereby inform to avail the benefits from the Scheme of direct sale from PSUs to Govt. organizations, if required, after obtaining the necessary approval from the Competent Authority with proper justification.

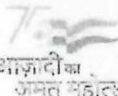
