Subject: Guidelines for implementation of revised Standard IS 8749:2024 — Biogas Stove"

- 1. Indian Standard IS 8749: 2002 has been revised and published as IS 8749: 2024. **The last date for implementation of the revised Standard is 05 February 2025**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

1.	Page 4, Cl. 9.3- Finish test for electroplated body	The corrosion resistance test for electroplated stove body has been deleted
2.	Page 8, Cl. 15- Requirements for strength test	Maximum allowed deflection has been changed from 4 mm to 2 mm.
3.	Page 11, Cl. 26	Resistance to draught has been added as new test
4.	page 11, Cl. 27	Fire hazard and limiting temperatures has been added as new test

- 4. Consequent upon publication of the Amendment, existing Product Manual has also been revised as Doc: PM/ IS 8749 /2/ October 2024. In this revision, changes have been made in Requirements of list of test equipment, and Scheme of Inspection and Testing.
- 5. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

(i) All Licensees shall implement the revised Standard by 05 February 2025. Any difficulty inimplementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no Licences are under operation Standard as per old standard after 05 February 2025. The status of implementation of the revised standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

- (ii) In order to establish conformity to revised Standard, licensee shall submit in-house or independent test report of the product for new tests (Fire hazard and limiting temperature and Resistance to draught), and modified test requirements (Strength test), as applicable, as evidence of conformity to revised Standard.
- (iii) Verification of implementation of the revised standard, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee.
- (iv) If the Licensee fails to complete all actions by 05 February 2025 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per old Standard. However, if the Applicant is desirous of considering the application as per revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails as per revised Standard, Licence will not be granted as per old Standard.
- (ii) Applications which are recorded henceforth may be processed as per old or revised Standard. Processing of Applications as per old Standard shall be permitted only up to 05 February 2025 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 05 February 2025.
- (iii) Beyond 05 February 2025 no Licence shall be granted as per old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per old Standard shall be permitted only upto the date of implementation of the revised Standard by the licensee or up to 05 February 2025 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
