# Subject: Guidelines for implementation of revised Standard IS 14756:2024 — "Stainless Steel Utensils"

- 1. Indian Standard IS 14756: 2019 has been revised and published as IS 14756: 2024. The last date for implementation of the revised Standard is 12 May 2025.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 4. Consequent upon publication of the revised Standard, existing Product Manual has also been revised as Doc: PM/ IS 14756 /7/ January 2025. In this revision, changes have been made in Raw material, Grouping Guidelines, List of Testing equipment and Scheme of Inspection and Testing.
- 5. The guidelines for implementation of the revised Standard is given below:

### A. LICENSEES:

- (i) All Licensees shall implement the revised Standard by 12 May 2025. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no Licences are under operation Standard as per old standard after 12 May 2025. The status of implementation of the revised standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensee manufacturers shall submit the test certificate of raw material (for 3-ply construction material) and test report (in-house or independent, as applicable) of the product of applicable variety (3 ply construction, utensil made from material as per IS 15997, externally coated cookware), as evidence of conformity to revised Standard.
- (iii) Since class of utensil (Heavy, Medium, Light, Commercial) is to be indicated in scope of licence now, licensees will be required to submit the declaration regarding class of utensils which are covered in their existing scope of licence. The declaration shall be examined and scope shall be revised by BO indicating class of utensil. Externally Coated cookwares which have been covered now in the Standard through this revision, shall be covered through process of inclusion of new varieties.
- (iv) Verification of implementation of the revised standard, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee.
- (v) If the Licensee fails to complete all actions by **12 May 2025** it shall be dealt with as per the prevailing guidelines.

### B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per old Standard. However, if the Applicant is desirous of considering the application as per revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails as per revised Standard, Licence will not be granted as per old Standard.
- (ii) Applications which are recorded henceforth may be processed as per old or revised Standard. Processing of Applications as per old Standard shall be permitted only up to 12 May 2025 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 12 May 2025.
- (iii) Beyond 12 May 2025, no Licence shall be granted as per old Standard.

### C. <u>CHANGE IN SCOPE OF LICENCE</u>:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per old Standard shall be permitted only up to the date of implementation of the revised Standard by the licensee or up to 12 May 2025 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
