**Subject: Guidelines for implementation of Amendment no. 2 to IS 17373: 2020
(Geosynthetics - Geogrids used in reinforced soil retaining structures - Specification)**

1. Amendment no. 2 to IS 17373: 2020 has been published. The last date of implementation of the amendment is **08 July 2024**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
4	The aperture size requirements have been widened from “50 mm to 500 mm” to “50 mm to 1000 mm” in Machine direction and from “10mm to 100 mm” to “10 mm to 150 mm” in Cross machine direction for Type 2 Geogrids.
Annexure-A	References of ISSs have been corrected/modified in Annexure-A.

3. Since, technical specifications have been relaxed for Type-2 Geogrids vis-a-vis aperture size and only editorial changes/corrections have been made in the referred standards, there is no need of submission of any evidence of conformity to the amended standard.
4. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
5. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after **08 July 2024**.
6. The above guidelines come into force with immediate effect.
