**Subject:** Guidelines for implementation of amendment no.1 to IS 16113: 2013–GAMMA PICOLINE

1. Amendment No. 1 to IS 16113: 2013 has been published with last date of implementation as 27 May, 2024
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause	Changes
<i>Page 1, clause 4.2.2.1</i>	<p>Additional sub clause 4.2.3 has been incorporated for test certificate for supplies of material in bulk as follows:</p> <p><i>4.2.3 For supplies of material in bulk, a test certificate containing the following information shall be provided for each container.</i></p> <p><i>a) Name and grade of the material;</i> <i>b) Name of the manufacturer and his recognized trade-mark, if any;</i> <i>c) Batch number;</i> <i>d) Supply date;</i> <i>e) Tanker number; and</i> <i>f) Quantity.</i></p>

3. As per the amendment, the requirement for test certificate for supplies of material in bulk has been incorporated. The changes does not require any modification in the existing manufacturing or testing infrastructure and therefore, does not require any evidence of conformity to establish compliance to the amendment by the licensee.
4. In view of above, BOs are requested to circulate this amendment to all the licensees and applicants immediately within 7 days of issue of this circular.
5. The above guidelines shall come into force with immediate effect.
