Subject: Packaged drinking water being sold by the name Alkaline water and Tata Copper Plus Water with FSSAI licence but without BIS licence-reg

1. This is with reference to the above.
2. Reference is also invited to CMD-2's email dated 28 Oct 2021 to all BOs informing that
 - i) As informed by FSSAI, Alkaline water and Tata Copper Plus Water are not qualified under the FSSAI standards of Non-carbonated water based Beverages (Non-alcoholic), the matter has been forwarded by FSSAI to their Central Licensing Authority, Chennai and Kolkata for taking necessary actions.
 - ii) FSSAI had further directed their FBOs to ensure that all the fresh licenses for Non-Carbonated Water based Beverages (Non-Alcoholic) to be issued strictly as per amended provisions and to comply with all regulatory requirements including obtaining a BIS certification for Packaged Drinking Water and Mineral Water, wherever applicable.
3. The above information was shared with a request to BOs that if any such cases come to notice, the same may be taken up with FBO's for further necessary action.
4. However, during a recent visit of DG BIS to Madurai, it was observed that in spite of clear directions from FSSAI, Packaged Drinking Water branded as TATA Copper Plus Water is being sold with a FSSAI licence, but without BIS standard mark .
5. In view of the above, all BOs are requested to take note of the above and coordinate with local food safety officers to ensure that packaged drinking water branded as Alkaline water, TATA Copper Plus Water etc is manufactured and sold only with BIS Standard Mark under valid BIS licence.
6. A compliance report in this regard shall be shared by all BOs with CMD-2 by email latest by **11th April 2022**.
