**Subject: Guidelines for implementation of Amendment no. 2 to IS 17266:2019 –
(Textiles – Viscose staple fibres)**

1. Amendment no. 2 to IS 17266:2019 has been published. The amendment shall be implemented with effect from **1 Oct 2021**.

2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.

3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

4. As indicated, there are only typographical corrections in the standard through this amendment. Accordingly, there is no change required in the existing product manual/SIT on account of this amendment (However, no. of amendments in the product manual to be read as 2).

5. Further, since the changes are editorial, no changes in terms of manufacturing/testing equipment or the product specification is necessitated and accordingly, licensees need not submit any evidence of conformity to the standard with the amendment.
