Subject: To ensure compliance to the containment measures for COVID-19-reg.

This has reference to the Order No. 40-3/2020-DM-I(A) dated 28 August 2021 of Ministry of Home Affairs, Govt. of India thereby directing that the Order of Ministry of Home Affairs of even number dated 29th June 2021, to ensure compliance to the containment measures for COVID-19, as conveyed vide Ministry of Health & Family Welfare (MoHFW) DO No. Z.28015/85/2021-DM Cell dated 28th June 2021, will remain in force up to 30 September 2021 (copy enclosed).

2. All officials of the Departments at HQs/ROs/BOs/Labs/NITS are, therefore requested to ensure the compliance to the said Order dated 28 August 2021.

3. It is further clarified that all officials of BIS shall attend the office physically on all working days without fail by following the COVID-19 appropriate behaviour/ guidelines issued by the Government of India from time to time. It is also reiterated that attendance registers shall be maintained in morning and evening (two times) for all officials on all working days till further orders.

4. The Competent Authority of the Bureau has expressed his unhappiness over the punctuality at BIS HQs. Therefore, all senior officers/HoDs of the Bureau are requested to ensure the punctuality as per the extant rules laid down.
