<u>Subject</u>: Guidelines for implementation of Revision of IS 1258: 2024 / IEC 61184: 2017 – Bayonet Lamp Holders

- 1. IS 1258:2005 Bayonet Lamp Holders has been revised to IS 1258: 2024 / IEC 61184: 2017 and the last date of concurrent running of the Standard with and without Revision is 25 December 2024.
- 2. The revision has been undertaken to align with the IEC 61184: 2017. The significant changes brought through this Revision is tabled below:

- 3. Consequent upon the Revision of Indian Standard, the Product Manual has been revised as Product Manual Doc: PM/ IS 1258/ 2/ October 2024 and is being circulated separately through BIS website.
- 4. The guidelines for implementation of the Revised Indian Standard is given below:

#### A) LICENSEES

- i. All Licensee shall implement the requirements of the Revised Standards by 25 December 2024. Any difficulty in implementation shall be brought to the notice of CMD III within 15 days of issuance of these guidelines. BO shall ensure that no Licences are under operation as per old standard after 25 December 2024. The status of implementation of the revised Indian Standard shall be confirmed by Head (BO) to CMD-III within 15 days of the last date of concurrent running.
- ii. Licensees shall submit the declaration and /or in-house test report / reports issued from BIS approved Labs as specified in the table of Sl. No. 2 above. The Licensees are also required to submit their acceptance to revised scheme of inspection and testing; or their own quality assurance plan as per the revised product manual.
- iii. Verification of implementation of the Revised Standard IS 1258: 2024 / IEC 61184: 2017 shall be done during the next surveillance visit, which shall be completed within one months from the last date of implementation.

iv. If the Licensee fails to complete all actions by 25 December 2024, it shall be dealt with as per the prevailing guidelines.

## B) APPLICATIONS FOR GRANT OF LICENCE

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory as per the earlier version of the standard may be processed without consideration of the revision. However, if the Applicant desires to get the licence with the Revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Revised Standard, Licence will not be granted as per the old version.
- ii. Applications which are recorded henceforth may be processed with or without Revision. Processing of Applications without Revision shall be permitted only upto 25 December 2024 and for such cases Applicant shall give a declaration that they will implement the Revised Indian Standard by 25 December 2024.
- iii. After 25 December 2024, no Licence shall be granted without consideration of the Revision.

#### C) CHANGE IN SCOPE OF LICENCE

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii. However, processing of such applications for change in scope of licence as per old Standard shall be permitted only upto the date of implementation of the revised Standard by the licensee or up to 25 December 2024 whichever is earlier.
  - 5. The above guidelines come into force with immediate effect.
