- 1. Indian Standard IS 13098: 2012 has been revised and published as IS 13098: 2024. **The last date for implementation of the revised Standard is 04 January 2025**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- **3.** The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 4. Consequent upon revision of the Standard, no change in manufacturing and testing facilities will be required for existing manufacturer licensees or applicants. Also, no evidence of conformity will be required to be submitted by the licensees, as compliance to the Amendment.
- 5. Consequent upon revision of the Standard, existing Product Manual has also been revised as Doc: PM/ IS 13098/3/ August 2024. In this revision, changes have been made in Scheme of Inspection and Testing.
- 6. All BOs shall inform the above to Applicants and Licensees under their jurisdiction.
