This has reference to the subject mentioned above and our earlier note Ref: CMD-I/2:12:1 dated 12 August 2021.

- 2) Vide aforementioned note, it was informed that GoL applications for 738 products are to be mandatorily processed as per option - 2 (erstwhile simplified procedure) w.e.f. 01 September 2021 in accordance with prevailing guidelines.
- 3) In this regard, following may kindly be noted:
 - i) The lists of products provided under GoL guidelines are dynamic in nature and subject to periodic review.
 - ii) Necessary changes in the ManakOnline portal have been made w.e.f. **01 September 2021** for processing applications of such products under option-2. Applications already recorded/submitted prior to this said date may be processed as per the selected option. However, starting from 01 September 2021 and onwards, any application submitted by manufacturers by non-selection of appropriate option may be summarily rejected.
 - iii) Under option - 2 for GoL, testing fee of sample drawn during applicant verification visit shall not be borne by the applicant and is to be treated as subsumed within the annual minimum marking fee.
- 4) This issues with the approval of the competent authority.
