Steps for observance of 'Communal Harmony Campaign Week and Flag Day 2024'

The following steps are required to be taken for observance of the Communal Harmony Campaign Week & Flag Day 2024:

- (i) To do campaigning and provide wide publicity for sensitizing officers, staff and public as a whole about the need for fostering communal harmony, National Integration and fraternity. Keeping in view the outreach, effective use may be made of social media, seminars, competitions and other activities etc.
- (ii) To make arrangements for circulation of fund collection boxes wooden, plastic or metallic boxes may be improvised with suitable openings to insert the donation.
- (iii) To select volunteers from amongst students and staff to station themselves at the entrance and other vantage points and go around the office buildings on the Flag Day for distribution of flag stickers and collection of voluntary donation.
- (iv) To make suitable arrangements for proper security of collection boxes, opening them, counting the amount so collected and sending to NFCH.
- (v) Remittance of funds so collected should be made through Demand Drafts/cheque in favour of <u>'Secretary, National Foundation for Communal Harmony'</u> and sent it to <u>Secretary, National Foundation for Communal Harmony, 9th floor, 'C' Wing, Lok Nayak Bhawan, Khan Market, New Delhi-110003</u> through Registered/Speed Post and not by courier.
