**Subject: Further Extension of time to micro scale toy manufacturing units for setting up in house testing facilities**

1. This has reference to the above.
2. Reference is invited to CMD-2's circular dated 17.12.2020 communicating that the Competent Authority has decided that licence may be granted to micro scale units manufacturing toys, without insisting on them establishing in-house testing facility under the condition that they shall establish the required in-house testing facilities within one year from the date of grant of licence.
3. A request was received from a Toy Industry Association to further extend the period till which micro units can operate BIS licence for toy safety without establishing required in house testing facilities. Information was also sought from BOs regarding establishing of in house testing facilities by micro scale toy units which had completed one year since grant of licence.
4. It has now been decided that BO heads shall review the status of establishment of in house testing facilities by micro scale toy units which had completed one year since grant of licence, and in such cases where micro scale units are yet to establish the required testing facilities, BO heads may grant an extension of further period of **nine months (i.e. total 21 months from date of grant of licence)**. No further extension beyond this period shall be permitted.
5. However, BO Heads are requested to ensure that it is verified during surveillance inspections that toy manufacturing units operating BIS licences including micro scale units are complying with the provisions of the Scheme of Inspection and Testing i.e. in case they are yet to establish in house or utilize cluster-based test facilities for the required tests, they are getting the samples tested at third party laboratories as per the frequency and maintaining suitable records thereof.
6. This is issued with the approval of the Competent Authority.
