**Subject: Guidelines for implementation of Amendment No. 2 to Indian Standard IS 9436: 2018- "Performance requirements and Methods of Test for Wheels for Passenger Cars, Quadricycles and Mini Goods carriers"**

1. Amendment No. 2 to IS 9436: 2018 has been published. **The last date for implementation of the Amendment is 25 January 2025.**
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the Amendment **within a week of issuance of these guidelines.**
3. The significant changes brought through this Amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the Amendment.

Sl. No.	Page and clause No.	Changes
1.	Page 1, Clause 1, Scope	It has been clarified that this standard is NOT applicable for Vintage Cars.
2.	Page 4, Material requirement for Cold formed Aluminium 5000 series	It has now been specified that Magnesium content for Rims of Cold formed Aluminium 5000 series shall be less than or equal to 3 %.
3.	Page 6, Annex- B- Information to be given by manufacturer at the time of testing of Rim	It has been clarified that Maximum Wheel load capacity is to be informed for testing.

4. Consequent upon publication of the Amendment, existing Product Manual has also been revised as Doc: PM/ IS 9436/4/ September 2024. In this revision, changes have been made in Scheme of Inspection and Testing.
5. The guidelines for implementation of the Amendment is given below:

### **A. LICENSEES:**

- (i) All Licensees shall implement the Amendment by 25 January 2025. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no Licences are under operation Standard without Amendment after 25 January 2025. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit the test certificate of raw material (*applicable for Cold formed Aluminium 5000 series only*) as evidence of conformity to the Amendment.

- (iii) Verification of implementation of the Amendment, shall be done during the next visit **which shall be completed within one month from the date of submission of compliance by licensee.**
- (iv) If the Licensee fails to complete all actions by 25 January 2025 it shall be dealt with as per the prevailing guidelines.

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without considering this Amendment. However, if the Applicant is desirous of considering the application considering this Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Amendment, Licence will not be granted without Amendment.
- (ii) Applications which are recorded henceforth may be processed with or without considering the Amendment. Processing of Applications without Amendment shall be permitted only up to 25 January 2025 and for such cases Applicant shall give a declaration that they will implement the Amendment by 25 January 2025.
- (iii) Beyond 25 January 2025 no Licence shall be granted without consideration of the Amendment.

**C. CHANGE IN SCOPE OF LICENCE:**

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without considering the Amendment shall be permitted only upto the date of implementation of the Amendment by the licensee or up to 25 January 2025 whichever is earlier.

6. The above guidelines come into force with immediate effect.
