- 2) After carrying out successful Search and Seizure operations, legal action is required to be initiated within the prescribed time norms.
- 3) These prescribed timelines have been reviewed and it has been decided that the BOs shall file case against the offender in appropriate Court of Law within 7 working days of carrying out successful search and seizure.
- 4) Timelines for launch of prosecution as mentioned above supersedes provision contained in SOP and Guidelines for Enforcement Activity Ref:CMED/GEN/5 dated 26 May 2023.
