**Subject: Administration of Integrity Pledge by DG, BIS - reg.**

**CIRCULAR**

Central Vigilance Commission (CVC) vide circular no. 20/09/22 dated 08.09.22 has informed that the Week from 31<sup>st</sup> October to 6<sup>th</sup> November 2022 be observed as the Vigilance Awareness Week, 2022. This year, the theme of Vigilance Awareness Week is "भ्रष्टाचार मुक्त भारत – विकसित भारत" "Corruption free India for a developed Nation". Accordingly, Vigilance Awareness Week will be observed in all offices of BIS from 31<sup>st</sup> October to 6<sup>th</sup> November 2022 in compliance with the direction of CVC as envisaged in their above mentioned circular.

2. As per the guidelines issued by CVC, Vigilance Awareness Week, 2022 is to be inaugurated at 1100 hrs on 31<sup>st</sup> October 2022 by administering a Pledge to all employees. According, DG, BIS will be administering the Integrity Pledge for Organizations to all BIS employees (including contractual staff) on 31<sup>st</sup> October, 2022 at 1100 hrs at the rear gate of Manakalaya.

3. All DDGs & HoDs at HQ are hereby requested to bring this to the knowledge of all employees working under them and to ensure that each employee does take the Integrity Pledge to be administered by DG, BIS. At ROs/BOs/Labs/NITS, the Integrity Pledge will be administered by the DDGR/HoD concerned.

4. Further, all DDGs/HoDs are also requested to encourage the BIS employees / contractual staff and their family members / relatives / friends and other stakeholders (BIS licensees/applicants, etc.) to take the Integrity Pledge for Citizens as an individual. A copy of the Integrity Pledge for Citizens is enclosed herewith.

5. All employees (including contractual staff) are requested to assemble at the rear gate of Manakalaya for taking the Integrity Pledge **at 1100 hrs on 31<sup>st</sup> October, 2022**. A copy of the Integrity Pledge for Organizations is enclosed herewith.
