Subject: Guidelines for implementation of Amendment No. 1 to IS 11313 : 2007 (Hydraulic Power Sprayers)

- 1. Amendment No. 1 to IS 11313 : 2007 has been published. The amendment shall be implemented with effect from **01 Feb 2022**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause no.	Change
Clause 6.2.2	Note under clause 6.2.2 stating that member are to suggest a minimum value of volumetric efficiency for roller vane pump" has been deleted
Clause 8.5.3	The parameter of "Power requirement" was already specified in IS 11313 however no formula was specified for calculation of the same. Now, formula for calculation of Power required to operate the sprayer has been specified through Amendment no. 1.
Clause 10.1	Marking clause: Following new marking requirements have been added: i. Rated Discharge Rate ii. Nominal Tank Capacity

- 4. There are no changes in the existing Product manual/SIT on account of this amendment.
- **5.** Since there are no technical changes in the standard through the above amendment licensees/applicants need not submit any evidence of conformity to the requirements of the standard with amendment. However, BOs shall convey the amendment to licensees/applicants and inform its implications to them and ensure compliance to the standard with amendment by 01 Feb 2022.
