Subject: **Observance "Communal Harmony Campaign Week" from 19th to 25th November 2022 and the Flag Day on 25th November, 2022 (Friday) of the National Foundation for Communal Harmony (NFCH) - reg.**

DoCA, vide their e-mail dated 19 October 2022 forwarding herewith a copy of letter ref. No. 5/1/2022-NFCH dated 3 October 2022 of the Secretary, National Foundation for Communal Harmony (NFCH) with a copy of letter ref. No. N-20/13/2022-P&C dated 19 October 2022 of the Joint Director, DoCA, on the subject mentioned above (**copy enclosed**).

2. In this regard, it is to inform that:

- (i) National Foundation for Communal Harmony (NFCH) observes Communal Harmony Campaign Week every year from 19 to 25 November. The last working day of the week is observed as the Flag Day of the Foundation. This year also the Foundation will observe **Communal Harmony Campaign Week from 19 to 25 November 2022 and the Flag Day will be observed on 25 November 2022 (Friday)**.
- (ii) The main activity of the said Foundation is to provide financial assistance to children rendered orphan or destitute in communal, caste, ethnic or terrorist violence for their education and rehabilitation under Project 'Assist'. The Foundation also takes up social, cultural and educational activities in collaboration with various partners for promotion of peace, unity and harmony in the country.



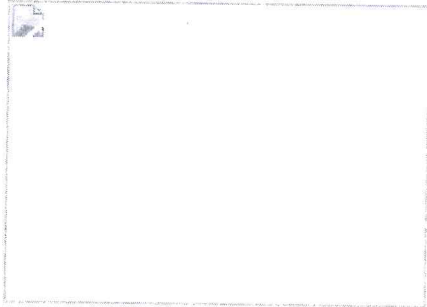



Steps for observance of 'Communal Harmony Campaign Week and Flag Day 2022'

The following steps are required to be taken for observance of the Communal Harmony Campaign Week & Flag Day 2022:

- (i) **Celebration of Communal Harmony Campaign Week & Flag Day 2022 may be observed under the prescribed guidelines of the Government of India pertaining to COVID-19 pandemic issued from time to time.**
- (ii) To do campaigning and provide wide publicity for sensitizing officers and staff and public as a whole about the need for fostering communal harmony, National Integration and fraternity. Keeping in view the COVID-19 pandemic, effective use may be made of social media, web based seminars and activities etc.
- (iii) To make arrangements for circulation of fund collection boxes – wooden, plastic or metallic boxes may be improvised with suitable openings to insert the donation.
- (iv) To select volunteers from amongst staff to station themselves at the entrance and other vantage points and go around the office buildings on the Flag Day for distribution of flag stickers and collection of voluntary donation.
- (v) To make suitable arrangements for proper security of collection boxes, opening them, counting the amount so collected and sending to NFCH.
- (vi) Remittance of funds so collected should be made through Demand Drafts/cheque in favour of '**Secretary, National Foundation for Communal Harmony**' and sent it to **Secretary, National Foundation for Communal Harmony, 9th floor, 'C' Wing, Lok Nayak Bhawan, Khan Market, New Delhi-110003** through Registered/Speed Post and not by courier.
