## Subject: Guidelines for implementation of Revised IS 302 (Part 2/ Sec 7): 2024

- 1. The existing IS 302-2-7: 2010 'Safety of household and similar electrical appliances: Part 2 particular requirements: Sec 7 domestic electric clothes washing machines (First Revision)' has been revised to IS 302 (Part 2/ Sec 7): 2024 'Safety of Household and Similar Electrical Appliances Part 2 Particular Requirements Section 7 Domestic Electric Clothes Washing Machines (Second Revision)'. The last date of concurrent running of both the Indian Standards is 13th April 2025 after which the existing IS 302-2-7: 2010 shall stand withdrawn.
- 2. The major changes in the revised IS 302 (Part 2/ Sec 7): 2024 are indicated below:
  - a) requirements for steam generators have been added in Cl. 3.1.9, 3.6.101, 19.101, 22.106, 22.107;
  - b) additional definitions for washing machine types in Cl. 3.5.101,3.5.102, 3.5.103;
  - c) temperature limits for external accessible surfaces have been revised in Cl. 11.3 and 11.8;
  - d) test procedure for the spillage test is revised in Cl. 15.2; and
  - e) additional requirements for appliances that are controlled by programmable electronic circuits that limit the number of heating elements and motors from being energized at the same time is added in Cl. 22.108
- 3. It is further informed that DPIIT has notified the product 'Electrical appliance for domestic clothes washing' as per IS 302-2-7: 2010 'Safety of household and similar electrical appliances particular requirements domestic electric clothes washing machines' for mandatory BIS certification under the Electrical appliance for domestic clothes washing (Quality Control) Order, 2023. The last date of implementation of the QCO is 04th September 2024.
- 4. The guidelines for implementation of the revised Standard are given below:

#### A. For existing licencees:

(i) Currently there are NIL licences as per IS 302-2-7: 2010.

## **B.** For New Applicants:

(i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.

- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto 13th April 2025 and for such cases, Applicant shall give a declaration that they will implement the revised Standard by 13th April 2025.
- (iii) In order to establish conformity to the revised Indian Standard, licencee/ applicant shall submit test report of the product, in-house or independent, as applicable, as evidence of conformity to the revised Indian Standard.
- (iv) Beyond 13th April 2025 no Licence shall be granted as per the old Standard.
- (v) If any Licensee/ Applicant fails to complete all actions by 13<sup>th</sup> April 2025, it shall be dealt with as per the prevailing guidelines.
- (vi) Any difficulty in the implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines.

#### C. For Inclusions:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto 13<sup>th</sup> April 2025 whichever is earlier.
- 5. The above guidelines shall come into force with immediate effect.
