Subject: Guidelines for implementation of Amendment no. 1 to IS 7532: 2018, Soft Soap – Specification

1. Amendment no 1 to IS 7532: 2018 have been published.
2. The product is under voluntary certification. There are 08 licences for the product and no applications pending for GOL in India.
3. IS 7532: 2018 with and without amendment no 1 are under concurrent running till 08 March 2025 and the last date for implementation of the amendment is 08 March 2025
4. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Major Changes due to the amendment to the IS

Sl no	Clause No	Change
1.	Page 1, clause 2	Referred ISs IS 286 and 1070 has updated with the year, 2018 and 2023, respectively
2.	Page 1, clause 3	Reference has been made to IS 286 as a whole, instead of '2 of' IS 286
3.	Page 2, Table 1	The table has been replaced and reference to specific clauses of IS 286 has been deleted
4.	Page 2, clause 7.1	Reference to IS 286 as a whole has been made instead of specific clauses of IS 286

5. Amendment no 1 shall be implemented by all Licencees/applicants by 08 March 2025. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 08 March 2025.
6. Since there is no technical change due to amendment no 1 to the IS, no evidence of conformity for amendment no 1 to the IS is required to be submitted and no change in the scope is ensued consequent to the implementation of the amendment
7. The existing Product manual has been revised to incorporate the changes due to the amendment to the IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/7532/2 January 2025
8. BOs are requested to circulate this guideline immediately to licensees and applicants for information.
9. The above guidelines come into force with immediate effect.
