**Subject: Guidelines for implementation of Amendment No. 6 and 7 to IS 15410:2003 for Plastics Bottles /Containers for Packaged Natural Mineral Water and Packaged Drinking Water – reg.**

1. This has reference to the above mentioned guidelines dated 22-11-2022 issued by CMD-2.
2. It is to submit that there are 5 licences under Scheme – I for Plastics Bottles /Containers for Packaged Natural Mineral Water and Packaged Drinking Water – Specification as per IS 15410:2003, which is under voluntary certification. As per present practice, the manufacturers of Packaged Drinking Water (PDW) and Packaged Natural Mineral Water (PNMW) usually procure packaging containers i.e. Jars Bottles from the BIS licenced manufacturers or procure preforms from the manufacturers who are not covered under the ambit of BIS certification.
3. Now, it has come to the notice through representations received from PDW manufacturers, that many of the PDW and PNMW manufacturers are being requested to submit adherence to amendment no. 6 & 7 of IS 15410: 2003 by few BIS Branch offices.
4. In this regard, it is to clarify that necessary documents including test reports for confirming compliance to amendment no. 6 & 7 of IS 15410: 2003 are required to be submitted to BIS only by the 05 BIS licenced manufacturers for IS 15410: 2003, as per the guidelines mentioned above.
5. In view of this, licencees for PDW/PNMW need not submit evidence of implementation of Amendment no. 6 and 7 to IS 15410:2003. However, it is requested to BOs to apprise the PDW/PNMW licencees of this amendment and they may be advised to ensure that future consignments of Plastic containers are conforming to IS 15410 including Amendment no. 6 and 7.
