**Subject: Extension of last date of implementation of revised IS 15820:2024( Establishment and Operation of Assaying and Hallmarking Centres- General Requirements(First Revision))**

1. This has a reference to the implementation guidelines of revised IS 15820:2024(Establishment and Operation of Assaying and Hallmarking Centres- General Requirements(First Revision)) circulated vide HMD circular of even number dated 29 July 2024 with the last date of implementation as 01 November 2024.
2. Considering the requests received from AHCs, it has been decided to extend the last date of implementation for clause 7.7 (Evaluation of Measurement Uncertainty) and clause 7.8.2 (Mandatory participation in Proficiency Testing) of the revised IS 15820:2024 to **31 January 2025**. All other clauses of the standard shall still be implemented as previously communicated by **01 November 2024**. The other terms and conditions of the HMD circular ref: HMD/14:44 dated 29 July 2024 remain unchanged.
3. All the Regional Hallmarking Officers are requested to inform the revised date of implementation for the aforementioned clauses to all the AHCs/Applicants immediately and ensure implementation of the same by 31 January 2025.
