Subject: Guidelines for implementation of Amendment No. 1 to IS 253 : 2014, Specification for Common Salt.

- 1. Amendment No. 1 to IS 253 : 2014 has been published. The amendment shall be implemented with effect from 01 October 2021.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Requirement
3.1.4, 3.2.5, Table 1	Requirement for chloride content (as NaCl) for dairy salt has been reduced from 99.6% (by mass), Min. to 97% (by mass), Min.

- 4. As indicated above, only the requirement for minimum chloride content (as NaCl) for dairy salt has been relaxed in the standard through this amendment. Accordingly, there is no change required in the existing product manual/SIT on account of this amendment (However, no. of amendments in the product manual to be read as 1).
- 5. Further, no changes in terms of manufacturing/testing equipment or the product specification is necessitated and accordingly, licensees need not submit any evidence of conformity to the standard with the amendment.
- 6. In view of the above, BOs are requested to ensure that licensees and applicants are made aware of the amendment and its implications.
