Subject: Guidelines for implementation of Amendment No. 1 to IS 398 (part 6):2021

1. The Amendment No.1 to IS 398 (part 6): 2021 'Aluminium Conductors for Overhead Transmission Purposes Part 6: High conductivity Aluminium Alloy Stranded Conductors' has been published. The last date for implementation of the amendment No.1 to IS 398 (part 6): 2021 is **28 Feb 2025**.

2. The significant changes brought through this Amendment is listed below:

Table 3	Addition of sizes with 833 and 911 mm ² Actual area

- 3. Consequent upon the publication of the amendment to the Standard, the Product Manual has been revised as **PM/IS 398-6/2/December 2024** and made available on BIS website.
- 4. All BOs shall inform the Applicants and Licensees under their jurisdiction about the above amendment immediately.
- 5. The guidelines for implementation of the Amendment No. 1 to IS 398-6: 2021 are given below:

A. For existing licencees:

6. The amendment does not require any action by the licensees towards its implementation.

B. For New Applicants:

- 7. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without considering this Amendment. However, if the Applicant is desirous of considering the Application with the Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Amendment, the licence will not be granted without the Amendment.
- 8. Applications which are recorded henceforth may be processed with or without considering the Amendment. Processing of Applications without Amendment shall be permitted only up to 28th Feb 2025 and for such cases Applicant shall give a declaration that they will implement the Amendment by 28th Feb 2025.
- 9. Beyond 28th Feb 2025 no licence shall be granted without consideration of the Amendment.

C. For Change in Scope of licence

- 10. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- 11. However, processing of such applications for change in scope of licence without considering the Amendment shall be permitted only upto the date of implementation of the Amendment by the licensee or up to 28th Feb 2025 whichever is earlier.
- 12. The above guidelines shall come into force with immediate effect.
