Subject: Guidelines for implementation of amendment no. 2 to IS 2631: 2020, Iso Propyl Alcohol

1. Amendment No. 2 to IS 2631: 2020 has been published with last date of implementation as 28 January, 2025
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
(Foreword, para 3)	Following has been inserted at the end: 'This standard does not prescribe requirement of isopropyl alcohol used for pharmaceutical uses.'

3. Through this amendment only the use of product has been modified in forward. therefore, no evidence of conformity for amendment no. 2 to the ISS is required to be submitted and no change in scope of the licence is required consequent to the implementation of this amendment.
4. BOs are requested to circulate this amendment to the licensee and applicants immediately within 7 days of issue of this circular.
5. No modification in the existing product manual (PM/2631/2, March 2024) is required consequent upon the issuance of the amendment no. 2 to the Standard. The existing Product Manual may be read as including the amendment no. 2
6. The above guidelines shall come into force with immediate effect.
