Beating Retreat Ceremony: (28 Jan 2023)	Officers equivalent in status to that of Directors to Govt. of India and above posted at Hqs only
Beating Retreat Ceremony: (29 Jan 2023)	Deputy Director General Posted at HQs only

Kindly note that as the attendance at the function is compulsory, only those officers who will attend the function positively, may apply for issuance of the invitation cards.

OFFICE MEMORANDUM

Sub: Republic Day Celebrations, 2023 – Issue of invitation cards - reg.

The undersigned is directed to refer to the subject noted above and to say that Ministry of Defence has informed that as in the past, admission to the seating enclosures for the Republic Day Parade and the Beating Retreat Ceremony, 2023 will be regulated through Invitation/Admit cards only to the entitled categories. Invitation/Admit cardholders will be allowed to bring children below 10 years of age, who will be seated in front on carpets.

2. For Republic Day parade on 26th Jan, 2023, officers of the rank of Under Secretary and above and equivalent in Govt. Ministries/Depts. will be issued invitation cards. For Beating Retreat ceremony (main show) on 29th Jan, 2023, invitation cards will be issued to the dignitaries figuring in the Table of precedence and officers of the rank of Directors and above in Ministries/Depts. of Central Govt. For 28th Jan, 2023 show, officers of the rank of Deputy Secretary and equivalent in Ministries/Depts. of Central Govt. are entitled.

3. As in case of PSUs/Autonomous bodies, etc. stationed in Delhi are only eligible, for Republic Day parade on 26th Jan, 2023, officers equivalent to the rank of Deputy Secretary to the Govt. of India and above will be issued invitation cards. For Beating Retreat ceremony (main show) on 29th Jan, 2023, invitation cards will be restricted only to CMDs and Board members. For 28th Jan, 2023 show, officers equivalent to the rank of Director in Govt. Ministries and above are entitled. Chairmen and members of the Commissions/Committees are also entitled to the invitation cards in accordance with their status.

4. The Invitation/Admit Cards will be issued only to those officers who have furnished their willingness for attending one and/or both celebrations. In this regard, eligible officers in the Dept. may submit their willingness and details to the Estt. Section. Further, Attached/Subordinate offices/Autonomous organization located in Delhi may submit willingness and details of their eligible officers to this Dept. on the email id: soestt-ca@gov.in.

5. The details are to be submitted **in the prescribed proforma only**. All star marked entries in the proforma are mandatory. The willingness and details shall reach Estt. Section **no later than 16.12.2022 (Friday)**. The timeline may be strictly adhered to. No communication received beyond the said date shall be entertained.
